Responding to parents policy

Due to current government guidelines regarding covid, and in order to ensure that we are able to respond to any queries you may have in an effective and timely manner, we would like to draw your attention to the following policy and ask for your support in its implementation.

The school will respond to parents within 5 working days of receiving an email, letter or phone call.

It will not be possible for a parent to be seen if they arrive at school without an appointment.

We expect parents to be courteous at all times during their communication with staff.

- **Telephone calls**

When a parent contacts the school by telephone, the office will take a message and the Wellbeing and Progress lead for your child's year will return the call as soon as they can.

- **Email**

If contacting the school by email, we would ask parents to use the school email address (see above).

- **Meetings with parents**

The school will always endeavour to hold meetings with parents in order to resolve any issues in a timely manner. To ensure this is possible, we would ask parents to contact the office on the usual number (see above) to arrange an appointment with the relevant Wellbeing and Progress lead at a mutually convenient time. If possible, there will be two members of staff present during meetings, one of whom will take notes which will be forwarded to all relevant parties. These meetings will not be recorded.

We are able to hold face to face meetings, despite the current situation, and we would ask that all parents respect the current covid guidelines issued by Welsh Government by:

- Completing the 'track and trace' form in reception
- Wearing a face covering at all times when on site, unless exempt
- Being aware of appropriate social distancing
